


It was thirty-two years ago this past summer that the Hector Carmichaels moved into "Birchwood Terrace", their new summer home near Omena Point, As with most of the vacationers who bought or built cottages, the Carmichaels made their first acquaintance with Omena through their friendship with another person who lived here. They had spent the summer in Harbor Springs and were on their way to Chicago. While spending the weekend at the Park Place in Traverse City, Mr. Carmichael called his friend Vercy Legg - a man well remembered by old Omena residents. Mr. Legg invited the Carmichaels to spend Sunday with him at his cottage, now known as "Bay Cliff", and only one day was sufficient for them to fall under the spell of Omena's irresistible lure. The land for their first cottage was immediately purchased from John R. Santo; the spring following, the cottage was built; and by summer it was ready for occupancy.

Thus began the strong and lasting ties to Omena of a man who was to become so much a part and benefactor of the resort, helping to preserve its unique natural beauty, quiet, and unspoiled atmosphere. At that time the only residents who still frequent Omena shores were the Newmans - then living at the George Anderson house; Mrs. Saxton; Mrs. Feeley, whose grandfather, Mr. Graves, owned the Point: and the Harry Clark family. living in one of their cottages on Ingall's Bay. Names such as Crabtree, Pierson and Spear were prominent among cottage owners on the Point. In the town proper Horace Wheeler's family were at Sunset Lodge, which at the time was a very popular place for members of some of Chicago's most outstanding families, among them the Andrews and the Nichols. Mrs. Carmichael recalls that it was not uncommon in those days for people on the Point to walk down what has recently been christened the "Ivy Walk", past Schram and Bauer, through the park in front of the present residence of the Carmichaels and up the hill to the Lodge for leisurely dinners.

In the 1930's, Mr. Carmichael, with a farsightedness that all of us are grateful for, acquired extensive Omena property. It included the hotel originally known as "The Oaks", and later as "Omena Bay Lodge", (tragically destroyed by fire several years ago), and 7 cottages with frontages extending roughly from Singing Sands down to and including the Pavillion which is now, of course, our Omena-Traverse Yacht Club. The home that the Carmichaels are now living in, with its wide-

sweeping and inspiring view of Omena Bay, was purchased several years after, and was used at times as a lodging house for chauffeurs of guests at the Omena Bay Lodge. The left wing which has recently been added was first located near Shorewood cottage, was then moved down near the Yacht Club and changed from there to its present situation.

Mr. and Mrs. Carmichael reminisce fondly over some of their happiest summers when they owned their first cruiser, the 41-foot "Restless", and went on numerous trips to the Manitou and Beaver Islands, to Fox Island and Charlevoix. Other jaunts were taken to the Mackinac Islands for the races. Later they acquired the larger 82-foot yacht "The Mignon", which had crew quarters for four and slept six comfortably. It is remembered by many of us as a magnificent boat. Because of the increasing difficulties of proper upkeep and finding adequate crews, Omena's largest pleasure craft was sold three years ago in Florida.

Mr. Carmichael was a prominent figure in the insurance world. While living in Michigan he was state agent for Commercial Union Insurance Company, later going to Chicago as assistant manager of Western Sprinklered Risk Association. He then organized the Oil Insurance Association and acted as General Manager until his retirement.

Ten years ago for reasons of health he retired from business and sold their Chicago house. It was then that Omena began to figure more as a permanent home in the Carmichael's life, though their winters were spent largely in Florida and Arrizona.

With an eye toward keeping Omena up with the times but yet retaining its pristine simplicity and beauty, Mr. Carmichael was instrumental in bringing about many adventageous changes in and around Omena. Among some of the projects he fathered and nursed along were the building of the back road along the Point to replace the shore road, which had become hazardous with increased auto speed and traffic; the installation of a water pump to furnish the Smith-White-Flett-Sloniker -Kinsey group of houses with running water. Of greatest and closest interest to all, however, was his fostering and encouraging the formation of the Omena-Traverse Yacht Club. As we learned at the end of the summer, his latest deed of generosity has been the donation of property surrounding the Club grounds.

Here, indeed, is a friend who has devoted much of his time, thought and money to the betterment of our summer resort. He can only be repaid in small part for his thoughtfulness and generosity by our continued faith and hope in his full recovery from his present illness. We all pay great tribute, too, to his wife, Jessie, who has been such a great help and inspiration to him.

# REPORT OF THE GROUNDS COMMITTEE

Your Grounds Committee has been doing some work since our closing meeting of the Club the week end before Labor Day. The roadway in front of the Clubhouse has been taken out and the ground in front and up to our north line has been covered with good black earth and seeded down so that we should have a fair lawn by next summer. We also put in a gravel walk from the front steps and around the flag pole to the dock. We believe you will like it.

Now as to the real estate end of our Club, the situation is as follows: As you all know at the start of our summer season we had title only to Lots 2 and 4 (see cut of Club property) which gave us something like 92 feet of water frontage and about 160 feet from front to back. We did not own our parking lot nor the woods behind it nor the land behind the Clubhouse on which our driveway is located, nor did we have any clear division of the vacated Ottawa Street along the north side of our property.

The above matters have now been taken care of and the Club now has 240 feet of frontage on Omena Bay and we have title to land some 320 feet deep and measuring about 210 feet in width across the back end of the property. This was accomplished by the very generous gift of Mr. and Mrs. Carmichael to the Club of Lots 5, 6, 7 and 8, which was announced at the last Club meeting, and their gift since then of Lots 1 and 3, and by a consent agreement with Mr. John Bauer as to the division of Ottawa Street. These transactions have all been handled by deeds which are properly recorded on the County Recorders books in Leland.


To make certain where our land started and stopped we have had this ground surveyed and concrete markers placed at each corner. The Club really has title to a fine piece of property — something we should all be proud of. Your Grounds Committee has gone ahead and done these things without authorization by the members because it seemed to the Committee that the time to do this was now and we felt you would all have agreed to these transactions had you been present.

There is only one "fly in the ointment" and that is that along with attorneys fees, recordings, surveying, marking and platting this property and revamping our front yard, we have spent over \$500.00. You don't need any auditor or C.P.A. to tell you that along with other fixed expenses, \$10.00 membership annual dues will not cover this money we have spent. We do not want to increase our annual dues, but if some of you are so inclined and financially able, the Treasurer can make good use of some donations to the Club at this time. Just send a good sized check to Stewart Ayars remembering that if every member put in \$500,00 we couldn't start over from scratch and replace this property.

The Abbots, Moores and Geo. Smiths drove to Omena for the Fall colors, the week-end of October 18.



#### COMMITTEE OBJECTIVES

The following list includes top priority objectives for respective committees. It is sincerely hoped that each committee will work actively on these objectives, plus giving consideration to developing the long range plans for the Club's future betterment.

Chairmen, please see that your committee functions so all may enjoy the benefits of a still finer Club.

#### HOUSE COMMITTEE

- 1. Step railings for exherior (pipe bent).
- 2. Upper porch rail screening (Expanded metal welded in place to present pipe rail, plus addition of bottom angle or pipe to which expanded metal will be welded. Finish paint screening of rail white).
  - 3. Strengthen inside balcony rail.
- Add fly screen to more windows, 1st floor main hall.
  - 5. New asphalt slate shingle roof. Patch and seal present roof for 1952 53.
  - 6. Work on future kitchen plans and needs. Kitchen to be built on present foundation in rear of stage. Prospective Kitchen Equipment needs. Raising funds for the above.
    - 7. Trophy case. Book case.
  - 8. Sealing off walls and ceiling, upstairs lounge.
  - 9. Columned porch and cupola.

#### YARD AND GROUNDS COMMITTEE.

- 1. Blade off clay and gravel of old drive in front or Club House, apply top-soil and seed for lawn this fall. Block off drive in rear of Club so all traffic goes to parking area.
- Complete walk, posts and planting around flag pole.
- 3. Remove all old boards, branches and rubbish from premises. All that is north of Club House and at rear and front of parking area.
- Plan for better planting and landscaping, and protection of land at water front.
- Secure small tools for grounds maintenance as Club property and provide tool shed on property.
- 6. Plan future development of grounds, and raising of funds to accomplish same.

## HARBOR DOCKS AND MOORINGS COMMITTEE.

- 1. Recover all race buoys, anchor chains, etc. Drain and store, this fall.
- 2. Store mooring chains and floats now at south of Club House, this fall.
- 3. Have stone from George Smith's added to south crib and break-water, this fall.
- 4. Plan for concrete topping of main dock out to wood deck.
- 5. Plan for extension of piles and walkway north of main dock for larger boats to tie up.
- 6. Clear out underwater spiles and menaces to north of main dock.
- 7. Secure mooring anchors(mushrooms). Secure floats for the above, we have chain

for at least three moorings, small, medium and large craft sizes.

- 8. Plan for sheet piling or sea wall at water front, so that both basins can have reasonable depth up to same when dredged out.
- 9. Design, erect a pull-out apron for Penguins and small craft, hinged to dock and floating outer end so boats can be pulled up on dock For the time not in use. This in place of beaching boats with attendant damage to bottoms.
- 10. Develop other additional needs and ideas for improvement of the harbor and the raising of funds for the same.

#### ENTERTAINMENT COMMITTEE.

- 1. Develop plans for next seasons activities.
- 2. Decide on needed additional facilities, which will make feeding, handling and serving, seating and clean-up easier to accomplish.
- 3. Work with House Committee on future kitchen plans and equipment needs.
- 4. Erect a refuse burner down by the south beach, of masonry with proper spark arrester screen, landscape around same, see Grounds Committee.

#### SPECIAL EVENTS COMMITTEE.

- 1. Plan for '53 activities.
- Appoint sub-committees for, parties, shows, music, decoration, etc.
- Consider development of stage, and stage equipment, etc.
- Investigate our P. A. system, and plan for its installation and use if desirable.
  - 5. How about a movie screen, etc.

# YACHT RACING AND BOATS COMMITTEE.

- 1. Plan next season's racing and regatta.
- 2. Events with other Clubs.
- 3. Secure race committee equipment, flags, shells for cannon, records.
- 4. Secure a loan of a boat for a committee boat for season.
- 5. Attend to racing buoys repair, paint and set out.
- 6. Erect a suitable storage chest and desk on dock with a flag-hoist for use of race committee.
- 7. Attempt to get all boats now in Club in races.
- 8. Establish a new class, perhaps Nationals which sell at around \$750.00 for a more advanced racing class.
- 9. Urge use of harbor by more craft of Club members.
- Attempt to get more boat owners in Club and Club members to be boat owners.
- 11. Secure trophies and ribbons for a-wards.
- 12. Plan for a Club owned launch and committee boat, its purchase, and the raising of funds for the same.
