

October 21 — Burnham Park Invitational, Burnham Park Yacht Club, Chicago, Illinois.



COMMODORE'S MESSAGE.

Your Commodore had planned to have a picture to send along with his letter showing you what Omena looked like on Easter Sunday. But bellows on the camera let in some light and the pictures were no good.

This is now the second Sunday after Easter according to the prayer book, for you who are Episcopalians, and the fifteenth of April or the Ides of April, to you who waited until the last day to file your return for the Bureau of Internal Revenue. It is also the deadline for items for the Breeze, so here goes.

To refer back to those Easter Sunday pictures, that didn't materialize, they would have shown from one to two feet of snow on the ground with absolutely no signs of Spring. The week following Easter, we had some warm days and rain and between here and Traverse City, a good size tornado, and we saw the bare earth for the first time since last November. This week end, while not warm or springlike, has brought out the early spring flowers. The Wheelers asked us up for cocktails between church and lunch and the Commodore brought Florence Wheeler a small bunch of Hepatica from the woods on the north side of the Ayars home and they were the first of the season.

The water in the Bay has gone down quite a little since you left last fall and this, of course, has changed the water front at the Yacht Club. So that you may get some idea of how things look, I might tell you that the dock in front of the Clubhouse, which is seventy feet long, has only twenty five feet that is in the Bay and this means that there is no water back of our south dock. In other words, our beach extends right out to a line from the south dock to a place on the big dock just twenty five feet from the end.

This shallow water means that we are faced with an immediate problem of moorings for the members boats. Your Commodore will have some figures and plans as to what we can do about moorings, so that your Directors can take action on this matter at their first meeting.

So that you may all make your plans accordingly, the committee appointments for 1956 are listed elsewhere in this Breeze. No big changes from last year because your Commodore was more than well pleased with his 1955 committees.

Ruth Bailey Swigart, one of the backers who has charge of operations as the producer, has a long background in professional Radio, Television and Theatre, including several seasons of summer stock as an actress in Chicago tent thea-

Plans for the coming summer are well advanced. Most of the resident company has been selected in New York and is under contract. Barnett Owen, last season's director, will be back as well as Helen Dayton, the stage manager and David Jones, the leading character actor. The balance of the resident company have all had long professional experience on the New York stage and the coming summer's productions should be outstanding.
