

COMMODORE'S REPORT

The first snow of the season came this Thanksgiving week and put the Yacht Club to sleep under its soft white blanket. Old Man Winter came along to put his seal of approval on all the last minute chores.

Although the Club was left in good condition, decorations having been removed from the Commodore's Ball very nicely, there were many other tasks to be finished. The porch furniture was moved inside, boats stored for the winter, the water system drained and lights and telephone disconnected.

You will also be pleased to know that the new windows have all been painted with two coats of good white paint on the outside and all window frames and sashes have been stained on the inside covering up most of the mars on the old frames.

All of this helps to give the Club a more ship-shape appearance, but it also helps to deplete the bank balance. Labor, paint, stains, and general repairs add up to a big bill very quickly.

As you remember, the middle tables at the Club were poorly lighted for our evening parties, when tables were needed. So we have put three new lights down the middle of the auditorium, all operated from a switch in the snack bar. I mention some of these items so that you will know when you read the Treasurer's report, why the cash on hand is not very big.

The only thing which cid not get done this Fall was the bringing in of the buoys. The "Jolly Roger" produced to get them in but due to motor 'rouble, had to return to Suttons Bay with our buoys still floating in Omena Bay. We will see what happens to them during the wanter.

You were very generous in the past season and gave the Cfub money to buy new Formica-top tables for our dinners, and new chairs which are needed at most of our parties. Your Commodore can report that the tables are now at the Club and are all in a steel frame on casters, so that when they are not in use they can easily be stored and rolled out of the way. The chairs have not been purchased yet because we have not decided which type is best suited to our needs. But we expect to have them on hand when we open next summer

The O. T. Y. C. has become an important item in the lives of the people who are fortunate enough to be in Omena during the summer, but we are not utilizing the Club nearly enough. Could we not use the Club more frequently than just

on Wednesday and Saturday evenings? Could we not make arrangements to have the Club open every day, conducting bridge tournaments, ping-pong matches, croquet, etc., so that we could make more use of our fine property? Any ideas from the members would be appreciated.

Since our Club was organized as a Yacht Club it seems as though our yachting activities need to be stimulated. We have not planned and executed a full yachting program for several years. It is my hope that we may secure the services of one of our adults to work with the young people with the idea of creating greater interest in sailing. You will receive a questionnaire from the Board of Directors asking you to give us your ideas as to what you want in the way of yachting facilities.

For a young Club, we have come a long way in a few years, but there is no reason why we shouldn't accomplish even more in the years ahead. Your Commodore appreciates all that each of you has done to make the past season so successful. Every job, no matter how small helps to make our organization an active one.

ANNUAL MEETING.

The Annual Meeting of the Omena Traverse Yacht Club for the year 1956, was called to order by Commodore Smith, at the Club House August 22. The Secretary's report was read and approved. Mr. Ayars then gave a detailed Treasurer's report, stating that at this date we have a total cash account of \$2,539.46.

Commodore Smith then gave an account of the improvements to the Club, which have been made during the last year, with special reference to our windows. The Commodore made the suggestion that perhaps we could have more activities for Club members such as croquet, pingpong, etc.

We then started voting on the proposals which had been posted during the year in the Club House.

Number one: That we raise the initiation fee to \$100.00. Mrs. Gleason moved that the Board devise a plan for re-instatement of members and that the initiation fee be \$100.00 for new members only. It was seconded by Mr. Abbott and defeated by a vote of 16 to 14.

Mr. Finn then moved that we postpone for one year, Mrs. Gleason's motion, for the purpose of amending it. This was seconded by Mr. DeVore and defeated 19 to 10.

Mrs. Gleason then withdrew her original motion,

Proposals numbered two, three and four,

That we limit membership.

That we make Junior memberships a must at the age of 14, and regular memberships a must at the age of 21 or when married.

And, that we raise the dues to \$50.00, were all tabled.

Proposal number five:

That we make addition to the dock so we can handle more boats. Mr. Farrell moved that the Secretary send a questionnaire to all members requesting information about what their needs will be for their boats, whether they will need moorings at the Club, what fee they would consider fair, etc. This was seconded by Mr. DeVore and carried.

The Commodore called for new business.

Mrs. Gleason moved that the Commodore appoint a committee to study the By-Laws and consider suggestions for revisions that would simplify voting, etc. This was seconded by Mr. Farrell and carried.

Mrs. Foltz announced that one of her house guests had noticed our shabby American flag and had sent us a new one.

Mrs. Gleason proposed that there be a junior board or council, the head of which would be an ex-officio member of the senior board.

Mr. DeVore then cast the ballot of the nominating committee as follows:

Mrs. Gleason moved that the members accept the nominations as read, seconded by Mrs. Feely and carried. Mr. DeVore moved for a vote of thanks to the Commodore and the Board, which was given enthusiastically.

Mr. DeVore moved that we adjourn, seconded by Mr. Flett and carried.
