


OMENA, MICHIGAN DECEMBER 1960





One of the most spectacular events in the history of the Omena-Traverse Yacht Club occured Saturday, August 27 when 11 lightnings assembled at the club to participate in an exchange regatta between the Traverse City Yacht Club and our own club. Earlier in the summer our Lightnings had participated in a similar event at Traverse City.

In addition to the lightnings the dock and harbor in front of the Omena club was a beehive of activity as other smaller craft and larger power boats anchored awaiting the start of the races.

The weather was ideal, wind just right and just a nip in the air to make the sail exhilarating. Crews and skippers scurried about making last minute adjustments and readying their craft for the test about to begin. The warning gun sounded giving all a chance to make last minute preparations and gauge wind direction and timing.

At last the starting gun was shot and the boats started out in a dead heat, maneuvering for position and edging their way to get the coveted lead. Committee boats powered out of the harbor and followed at a safe distance.


By the mid-point of the first lap, boats had begun to thin out and several emerged in the lead. Soon an appreciable distance was noted between the lead boats and those following. Of the six boats from the Traverse City Yacht Club, three were among the leading boats and our own Norm Johanning was a strong fourth contender.

Once the leads were established, there was no change in position for the entire race. The final results were, first - the Cline's from T. C., second - the Taylor's of Suttons Bay, third - the Cornwell's of T. C. and fourth - the Johanning's of Omena.

Following the race the visitors and their families along with the skippers and families of the OTYC members were guests of the Club at a dinner on the lawn of the George Smiths.

Everyone was enthusiastic about the event and are eagerly looking forward to another exchange of regattas to be scheduled for the summer of 1961.

Omena may well be proud of its Yacht Club for it is the center of yachting activities in this area as well as the social center for summer residents and local residents. An expanded activities program has justified the expenditure of monies for club improvements and the new docks are already filled so that we may well need to consider expanding slip facilities within the near future.

COMMODORE'S MESSAGE

As your new Commodore sits down to write a message to you he just can't help but sit back and mentally reminisce. For Omena is a delightful place that gets into the blood of all of us. Whether we are there for two weeks or all summer, our stay seems unbelievably short. We leave regretfully, recall pleasant memories during the winter, and in the spring look forward eagerly to our return.

Omena is not only a place, but a state of happiness and enjoyment. In this pleasant atmosphere cares are forgotten, old friends enjoyed, new friends made, and romance flourishes. For evidence on this latter point you will find in our membership list about twenty-five wives of Yacht Club members who are daughters of Club members. Your Commodore happily confesses that Omena's delightful environment played a large part in his own romance.

There are many factors that have contributed to making Omena what it is - the water, the woods, our friends. There is our summer cottage - large or small, new or old - which we enjoy tremendously as it is, but dream about what we can afford to do next year to improve it.

One of the most important factors in Omena's way of life is our Yacht Club. No other single thing has done as much to create our community life, to bring all of Omena together. It has become the center of our summer activities - offering something to everyone. I am sure that the Founders, in 1948, did not envision the high place the Yacht Club now occupies in our summer life.

You can be proud of Omena-Traverse Yacht Club - its building, its grounds, and its facilities. Few yacht clubs in Northern Michigan can top it in those respects. Few can approach it in its place in the community.

You can be proud of the progress the Club has made in the past twelve years. When the Club started in 1948 it had a rented clubhouse with no rest rooms, no kitchen, a narrow, dangerous road, and remnants of a dock. Compare that with what the Club now has. It owns the clubhouse with 332 feet of frontage on the bay, and you are familiar with all of the improvements. This has been made possible by the generosity of Hector and Jessie Carmichael. the continuing support and liberality of the Club members, and the devoted efforts of the Club Officers and Directors. I am sure that everyone who participated is proud of the result.

In 1959 the Club Directors authorized a five point Improvement Program —

- 1. Widen and rebuild the entrance road.
- 1. Purchase additional land.
- 3. Rebuild and enlarge the dock.
- 4. Construct a tennis court and related facilities.
- Institute a Youth Activities Program, with a paid Director.

The road is rebuilt. Four more lots with 92 feet water frontage have been purchased. The dock has been rebuilt and greatly improved. The Youth Activities Program with Director operated last summer with great

interest and success. The tennis court is cleared, graded, provided with water, back stops, and access steps, and is ready for an all-weather surface when funds are available.

When your Commodore, then Chairman of the Finance Committee, arrived in Omena last June he found that the amount available in the Improvement Fund, plus pledges due in 1960, was not sufficient by about \$1,550 to pay for the above Improvement Program. This looked like a pretty high hurdle to try to clear. However, the Finance Committee tackled the situation with determination. With outstanding efforts by Don Patterson, and assistance from Bill and Doug Graf, John Roth, and Ed Oberndorf, donations and pledges were secured to the extent that as of November 1, 1960, all current Improvement bills are paid. A Financial Statement of the Improvement Fund appears elsewhere in this issue. The thanks of all the Club members is due those who contributed so generously.

Contributions of time, material, and equipment, in addition to financial assistance, are too numerous to list here. However, special mention is made of Norm Johanning's gift of the electric pump and piping for the water system to the tennis court, and buoys for the sail races.

Mention should also be made here of the contribution by Frank Kalchik. While building the new dock, Frank ran into unexpected conditions he had not figured on. Rather than cheapen the construction to offset the increased cost, he continued to build the best dock possible, and donated the extra cost of \$450 to the Club.

Another forward step by the Club was the employment of a permanent Bookkeeper to maintain its financial records. This was first suggested by Ray Flett in 1959, and some preliminary investigations were made. The Directors authorized going ahead in 1960, and Mrs. James Moe of Suttons Bay now is in charge of maintaining the Club's books. Mrs. Moe is Suttons Bay Township Clerk-Treasurer. The advantages of this arrangement are, first, that our choice of a member for the position of Treasurer is not restricted to one having accounting experience; second, that it provides a continuity with respect to the knowledge of and handling the Club's financial records regardless of frequent changes in the Club Officers.

We all regret the illness that prevented Joe Alcorn from continuing as Commodore a second year. Joe has been one of the stalwarts in the Club, and has contributed greatly to its success in every way. We look forward to his being with us again next summer with restored health.

Last summer was a good one at our Club. The Wednesday night dinners, long one of our most popular attractions, enjoyed capacity crowds most of the time. Did you know that the "After Labor Day Group" continue these dinners well into October? Our Youth Activities Program was very successful. The sail racing in the Lightning Fleet was very active with much spirited competition, and indications are for greater interest and participation next summer. The extensive Improvement Program has been

mentioned. Yes, it was a good summer. Next year? We have plans and ideas,

Next year? We have plans and ideas, and are working on some innovations suggested by members. But let us wait on them for the Spring issue of the Breeze.



YOUTH ACTIVITIES PROGRAM 1960

Members of the Yacht Club may take pride in the success of the first Youth Activities Program held last summer from July 4th through August 22nd. Judy Selby from Suttons Bay served as full-time counselor teaching tennis and swimming. Sailing classes augmented the regularily scheduled program thanks to the enthusiastic help of Linda and Al Cherne (and the Johannings Lightning "Queen Bee").

Two outings were held during the summer. Over forty children, carrying their lunches, participated in a trip to Petersen Park to swim and another trip to Northport Municipal Beach as guests of the Northport children's program.

Thanks to George Smith the tennis program was not hampered due to problems with our newly built court at the Club. Using the Smith's court every morning the 7-9 year old group averaged six students; the 10-12 year old group averaged 12 participants and those over 12 years of age had on the average of 8 each week. In a tournament, Bobby Trautman was the champion and will remain in first place until next summer.

In spite of the unusually cold water which prevailed in the Bay, swimming classes brought out striking improvements in all age groups. The Beginner classes averaged six children until the last two weeks and over 10 were participating in the Intermediate group. Judy had a fine class of over 14 in the advanced swimming group and issued Swimming Certificates through the Red Cross to the following:

A highlight of swimming among the pre-teen group was a swim across Omena Bay accompanied by Judy and Linda Cherne in motor boats. Nine children swam from the Yacht Club to the Pike's dock.

George Smith made possible two fine badminton courts and the children were using the racquets during class hours and at other times at the Club. We hope that members noticed an improvement in the general behavior on pot-luck nights. Judy made great strides in waterfront safety and dock rules with all age groups.

The Ingalls Bay residents were kind enough to let the swimming classes use their beach for soveral weeks until proper safety equipment could be installed on the Club waterfront. The Youth Activities Committee would like to thank all the mothers who helped supervise on a volunteer basis after the swimming lessons resumed at the Club. It was of immeasurable help to the counselor who could not under any circumstances leave the dock when children were in the water to supervise land and club house activities.

Your Youth Activities Committee for 1961 will consist of Mary Huff and Ainee Paterson as co-chairmen; Linda and Al Cherne, Bob and Jane Newland and Joan and John Roth members. An important questionaire has been mailed to all families whose children participated in the program last summer. The committee asks that they be filled out and returned immediately as it will be too late for major changes next summer after the hiring of a new counselor has been completed and the program planned. The board of directors has unanimously agreed to help support the program financially. We all hope to benefit from our brief experience and improve the program each year within the wishes of a majority opinion of members.

The Board of Directors and the Youth Activities Committee would finally like to express its warmest thanks to Judy Selby for her enthusiasm, patience and devoted work with the children. She met the obstacles inherent in any new project and made possible a summer which we had not dared dream could come true. She kept purchases at a minimum and used existing equipment at the Club.

Mrs. Hector Carmichael donated a fine

portable record player and it is hoped another year that water ballet, square dancing and other such things will be possible at the Club. For long distance swimming, the Gleasons loaned us their Dinghy for Judy to use while life guarding for which we would also like to say "thank you".
