# Omena Lake Becomes O.T.Y.C. Dream for Future

At the first OTYC Director's meeting last summer Jessie Carmichael gave the Directors an unexpected and pleasant surprise when she announced that she would like to make a gift to the Club of Omena Lake and three lots connecting the lake with Omena Bay. Naturally, the Directors were extremely gratified at this offer and, after expressing their great appreciation to Jessie, voted unanimously to accept it for the Club.

This substantial gift is one more of the many acts of great generosity toward our Club by Jessie and Hector Carmichael, without which OTYC would never have arrived at its present fine club house and surrounding property. From the beginning of OTYC the Carmichaels have been very interested in it and have contributed immeasurably to its growth and development.

Many of our members may not have been aware of Omena Lake. Some probabdy have thought of it as the lake back of the Presbyterian Church on the Ingalls Bay road. That lake is officially known as Mougey's Lake, although it has been improperly named Omena Lake on some fanciful decorative maps.

Omena Lake, about one quarter mile long, has its northern end a few feet south of the entrance road to OTYC. It lies between the Omena Point road to the East and the low bluff to the West on which many of the cottages facing Omena Bay are located. The growth of reeds and bushes around the edges of the lake in recent years has made it look like a swamp. However, Dr. Bill Graf took aerial pictures last summer that show clear water in the center of the lake, even with the low water level then existing. There have been occasions in past years when clear water came practically to the OTYC entrance road.

The three lots, Nos. 27, 28, and 29, are about two thirds of the way down the lake See CARMICHAEL GIFT Page 4

The Annual Meeting of the Omena Traverse Yacht Club was held August 21, 1963 at the Club House, Commodore Renz presiding and 48 members present.


Mrs. Smith moved, and Mrs. DeVore seconded to dispense with the reading of the minutes of the last meeting. Motion carried.

He stressed safety in boating, and stated that classes in safe boating, and artificial respiration would be given next year, with the co-operation of the Coast Guard. He announced the gift of Mrs. Carmichael of the property known as Omena Lake and additional property to provide an outlet to the Bay and asked that a resolution be made and sent to Mrs. Carmichael, showing our appreciation to her for all that she has done. His entire report has been filed for reference. On announcing Mrs. Carmichael's gift, Robert Morse showed pictures of a map showing in detail just where the property was, and also pictures taken by Dr. Bill Graf and himself of the property as it is today.


#### Committee Reports

Harbor and Docks: Robert Morse, Chairman. The water level is very low, and because of this one slip has not been usable. It was decided not to do anything about it this year, but if the level does not rise next year, it will have to be dredged out. A small amount was done this year, but the sand slipped back. One corner of the dock is loosing the rocks and is causing settling. There are two courses of action: one is to get inside and replace the stones, or to remove the concrete on top and fill in. Frank Kalchik will be asked to advise and the proper work will have to be done.



and extend from the lake to the bay. They lie between the Boucher (formerly Queenie Smith) cottage and the Rogan cottage. They are located at a point where there is a low opening through the bluff so that the level of the lots is only a little higher than the normal level of the lake. Presumably, this was at one time a connecting channel to Omena Bay, and the purpose behind the gift of these particular lots was to provide a place for a possible future channel that could be built most easily.

If Omena Lake were cleaned out and developed, and a connecting channel to Omena Bay built, it would provide a wonderful landlocked harbor and site for a marina. This idea has intrigued various people in recent years, some of whom have approached Jessie about it. However, she feels that control of the development and operation of such a project should properly be in the hands of OTYC to protect the best interests of the Club and the community.

Jessie knows, as do the Club Officers and Directors, that such a development would no doubt have to wait some years, but she feels satisfied that at least it will now be in the hands of those who would handle it as she would like to have it done.

All our Club members, Officers and Directors, feel deeply grateful to Jessie Carmichael for her generosity and concern for the future of OTYC.

### Commodore's Report

Our Omena Traverse Yacht Club is sixteen years old this summer, and as we look back over the years we can well be proud of all that we have accomplished. To those who have preceded me as Commodore, and to all who have worked on Committees, great credit is due, and it has been my privilege this summer to carry on what they have started.

Before our opening dinner on July fourth, committees had been at work getting things ready for the summer. Harold Root, Chairman of the House Committee saw to it that the Club House was cleaned, general repairs made, and given a bright new coat of paint. The Grounds, under Preston Smith, were kept in shape, the tennis court area reseeded and fertilized. Ladders were added to the dock area so that boats could be boarded with greater safety. Due to the low level of the water, a new diving platform and ladder were necessary and have been supplied. A water heater, the gift of the Donald Pattersons, has been installed in the kitchen, and hand dryers placed in the two wash rooms.

Our season officially opened July fourth with the traditional Turkey dinner. Under the able supervision of Leona and Bill Milroy, their committee served 104 adults and 15 children, and made a profit of \$142.66. This is our big money making project of the year. Our sincere thanks to Mrs. Milroy and her committee. Our usual Pot luck suppers have been held each Wednesday night and will continue for some weeks. One dinner, for "adults only" was held in July with 63 members attending. Mary Lou Root, Chairman of the Social Committee, planned several Bingo parties, a picnic and "Sing", with more than 100 attending; an evening of pictures of Europe by our own past Commodore, Bob Morse; and of course, the Commodore's reception.

The Tennis Courts have been extremely busy, sailing has taken up the Sunday afternoons, and the Youth Program, under Pam De Boer has filled each day with some activity. It is rare to come to the Club

House and not find some activity going on.

I want, at this time, to urge more of you to come to the Club House Sunday afternoons during the racing, and stay for the refreshments served by Margaret Koch and Marian Finn, and visit with the sailing crews and other members of the Club for a social hour.

Our Club was represented at the George Smith Memorial Race at Traverse City by the boats owned by Carl Koch and Norm Johanning.

For the first time, a general meeting was held in July, the purpose being to acquaint the members of the activities of the club and receive suggestions for the future.

18 members attended.

The Board of Directors have met and wish to go on record as approving the following:

- 1. Mobile homes or house trailers shall not be allowed to park on Club property.
- 2. Those who rent their cottages tell their renters that guest memberships are available, and that notices to that effect be placed in the cottages. Guest memberships are \$5.00 per adult member, and \$2.50 for children between the ages of 14 and 21.
- 3. That adequate wiring be placed in the club house. At present the wires are overloaded, and as a safety measure, old wiring should be replaced and additional circuits be installed.
- 4. That we give the Sheriff's department of Leelanau County, Marine Safety Division, \$25.00, to be used toward the purchasing of resuscitation equipment to be used in teaching.
- 5. That copies of safety rules be placed on the dock and rules for regulating play on the tennis court be posted.
- 6. Prospective members shall be guests of the club twice before submitting applications.
- 7. That the Omena Traverse Yacht Club be represented in both Sail and Power Squadrons of the Lake Michigan Yachting Association.

Since our terrible tragedy this summer, we have planned a definite safety program for the remainder of the year, and for next season. A gift, offered by a friend of the Club, has been received, and will be used for the promotion of safety, as requested. We have received literature from the Coast Guard, Coast Guard auxillary, and the

Sheriffs department of Marine Safety, on safe boating, and classes will be given next year.

The outstanding news of the year was the gift of Mrs. Carmichael to the Yacht Club of the land known as "Omena Lake", and additional property to give an outlet to the Bay. For some years we have talked of this property as it could be used as a wonderful land locked harbor. This is, of course, a very long range plan, but with Mrs. Carmichael's generous gift, we can control the use of the land and look ahead to future development of club property. We are all very thankful to Mrs. Carmichael for this gift as well as for the many gifts she has made in the past. Without Mrs. Carmichael, and her husband, Hector, the Omena Traverse Yacht Club, would not be what it is today.

Serving as Commodore this past year has been a busy time, but enjoyable to me. I want to express my appreciation to the enthusiastic support of the Club members, committee chairmen and their members, the Board of Directors and other officers of the club. Although Omena has had a new fire house for several years, the only fire fighting equipment in it has been a small two-wheeled trailer carrying a gasoline engine driven pump. This pump was to be towed to a fire behind Keith Brown's service truck and somehow gotten to the water's edge. This would be difficult in many places around Omena, and of no use where the fire was some distance from the water.

Recognizing the potential danger to the community, a group of summer and permanent residents organized the Citizen's Committee for the Omena Volunteer Fire Company, with Fred Weiss as Chairman, to secure voluntary contributions to a fund to purchase a fire engine with proper equipment to handle Omena's fire problems. Solicitation last summer met with enthusiastic and practically 100% support, so that the Committee now has a fund of \$3,153. Contributions came both from summer residents and from permanent residents and business men of the Omena Community. These contributions have been ruled tax

deductible by the Internal Revenue Service.

With the fund solicitation a success, the Committee met with the Leelanau Township Trustees, accompanied by Orval Kellogg, Chief of the Northport Fire Department, of which the Omena Fire Company is a branch. The Trustees expressed great appreciation for the Committee's efforts and promised full cooperation, including maintenance of the new equipment and heating of the fire house.

In selecting and finding the proper type of equipment for Omena's conditions the Committee was greatly helped by Chief Kellogg, and particularly by Mr. Gannon of The University of Michigan Fire Prevention School. The result was that in October the Committee arranged to buy a used fire engine from the Fire Department of Elsie, Michigan.

This engine has a two stage pump and carries, in addition to the usual equipment, a 500 gallon water tank. In a large percentage of fires this 500 gallons of water is sufficient to put out the fire. The present engine driven trailer pump will be taken off its trailer and carried on the fire engine. It can be carried to the water's edge to supply water to the engine pump if the 500 gallon tank is exhausted. Although used for a number of years, this fire truck has only 6000 miles on it, and Chief Kellogg says it is a better engine than the one at Northport.

The cost of this engine is such that sufficient funds will be left to buy all the additional equipment needed, including 500 feet of new hose. It is also the intention to buy a fire siren to mount on top of the fire house to quickly call members of the Fire Company.

The only rub in the situation is that the fire engine will not be available until next May, as Elsie's new engine will not be delivered until then. This situation would occur in any purchase of a used engine. Meanwhile, the Omena Community can look forward to a state of preparedness against fire that they have never before enjoyed.
