## Commodore's Message

Omena Bay Saturday, March 31, 1984

As we sit on our porch and look out over Omena Bay, Carla and I are again reminded of Omena's beauty. The blue water sparkles under thin layers of icc while the mouth of the bay is covered with a blanket of snow and ice. The contrast of the clear blue sky and the blue/white Bay against the gray/green tree line is magnificent. It is hard to imagine a more beautiful place on earth.

For those who are not in Omena during the winter, Christmas was a skiler's delight. The heavy December snowfalls appear to have remained the entire winter, although there was not alot of new snow after December. We are told that the ice has been out of the Bay twice already this year. Out over the back door, the two foot high snow drift is a reminder of how slowly our long, Michigan winter dies.

A brief tour of the Yacht Club indicates the club survived the winter in pretty good shape. Bob Harper, chairman of building and grounds, tells me the lumber is in for the new steps to the tennis court. The work should be underway in the next few weeks. Kevin had been a club member and involved in the sailing program for many years. His knowledge and enthusiasm make him an ideal person to handle our program. All Kevin needs is a flock of eager youngsters (and adults) to make the summer program a great success.

The 1984 tennis instructor has not yet been selected. Jonnie Hodgson, chairman of the tennis committee, has informed me that Tom Goodspeed is unable to return this summer. We are sorry Tom could not return and wish him well. We are presently in the process of reviewing resumes for his replacement. We will have a capable instructor ready to go in July.

The 1984 Social calendar appears in the Breeze. Some of the highlights include Suzie Mulligan's famous "auction" and the summer dance set for August 11, 1984. While details

of the dance are still being worked out, we hope many of you will be able to attend.

Being relative newcomers to the Omena area and OTYC, we are going to need a lot of help and guidance this summer. If you have suggestions or comments concerning the operation of the club, please feel free to let me know.

As we begin to understand all of the activities (and responsibilities) undertaken by our club in eight short weeks, it is almost overwhelming. Just now am I fully realizing and appreciating the fantastic job Barb and John Harris have done over the past two years.

OTYC has a long outstanding tradition of providing a good, wholesome learning environment for our children and a rich, pleasant fellowship for our adults. This tradition is carried on because our members are willing to contribute their time and effort. Everyone's contribution is important.

Carla and I look forward to seeing all of you in Omena this summer.



The minutes of the 1982 Annual Meeting were read and approved with the correction that Blanche Moore and Earl Moore were not present.

D.J. St. John, Treasurer, presented the Treasurer's Report. Cash balance on hand as of July 15, 1983: \$11,047.40. D.J. stated that almost all of this year's dues have been paid and that the Youth Membership (ages 14 to 24) dues were raised to \$11.00. A youth membership is billed, based on the youth's age during the year of membership and the year a youth member becomes the age of 24 the youth will be charged the adult rate with full voting privileges. It was suggested that clarification of the youth membership be published in the next O.T.Y.C. Breeze.

#### Sailing:

Fred Schwarze announced that there is a new set of tennis rules on the board. The only difference is that the sign-up time will be no sooner than 24 hours in advance of court time and if you do not show up by 10 minutes after the hour, your time is forfeited and the court is considered vacant and open for anybody to use during that period.

#### Social:





### LEELANAU MEMORIAL HOSPITAL CHARITY BALL

An important Autumn event on the Leelanau Peninsula is the Charity Ball sponsored by the Leelanau Memorial Hospital Auxiliary.

This fall on October 1st the Leland Lodge was host and the Jon Peterson Trio of Interlochen provided fine music.

Major gifts and hundreds of smaller gifts over the years have made it possible for the Hospital to expand its capabilities, medical equipment and services. The Patron proceeds of this Ball were directed toward the purchase of a new automatic Cell Counter which counts red and white cells.

We are especially proud of our Omena Auxiliary members who carried the major responsibility for this successful affair this year. We are also grateful to many Yacht Club members who were patrons.

Elizabeth Keye was General Chairman, Bob Harper Financial Chairman, Chris Misangyi Publicity Chairman and Gennie Grossman Correspondence Chairman.

Financial contribution to the hospital from the Charity Ball was over \$6,000.



#### From the House & Grounds Committee:

The re-wiring of the Clubhouse is complete. This involved removal of the old "single strand" wiring, replaced by a three-wire grounded system, replacement of all old receptacles, installing lots of new switches including "dimmer" type, new overhead fixtures for the balcony room and the activities room, and the grounding of kitchen light fixtures. The chandeliers in the ball-room and bar have been re-wired.

The security light is now mounted on its own pole at the corner of the parking lot so the bugs will be drawn away from, not towards, the Clubhouse.

The treated lumber for replacement of the stairway to the tennis court is on hand — the job to be completed next Spring.

The Clubhouse has been winterized and is in hibernation until Spring comes again.




