

TO ALL O.T.Y.C. MEMBERS,

It has been brought to the Board of Directors' attention that several members have been in violation of our family membership rules by paying single membership dues. Article VIII, Section C, plainly states that all married members are required to pay a family membership dues of \$110.00 per family.

The Membership Committee has also encountered members' married children using the club's tennis court, clubhouse, boat ramp, etc. It is necessary for married children to have their own family membership, Article XIII - Member-

- a. A family membership shall include a husband and wife and their children under the age of fourteen.
- b. A single-adult membership is available to unmarried persons eighteen years of age and over.
- c. Junior Membership Unmarried children of members, 14 years of age and up to the age of 24, must become Junior Members in order to use the facilities of the club. No initiation fee is required for junior membership. A junior member may, after the age of eighteen, elect to become an adult member and to pay adult membership dues. A junior member shall not be entitled to vote on club business.

We would hope all members in violation of club policies will correct them immediately without further notice.


NOTES & COMMENTS FROM MEMBERS ALL OVER

In Memoriam

Dan T. Bradley Commodore, 1966-1968

OTYC members extend their condolences to Eloise Bradley, whose husband passed away on March 18 in Kansas City. Dan was born in Grand Rapids, Michigan and moved to Kansas City as a child. He met Eloise when they were 4 years old and enrolled in the church kindergarten. A graduate of Oberlin College, he was a 50 year member of the Society of Automotive Engineers. As an engineer, he was a founder and Chief Engineer of Harris Products. In addition to Eloise, Dan is survived by his daughter, Barbara Hildner, six grandchildren and two great-grandchildren.

From the May, 1968 Breeze, Dan related the following about his family:

"Yes, Dan Beach Bradley was my grand-father; he was a medical missionary in Siam from 1835 to 1873 at the time of his death. A considerable part of his work was with the Printing Office of the then American Missionary Association. He left the former because of too liberal a theology. In 1863 the Print Shop was behind the Upper Fort, near the palace of H.R.H. Prince Krom Hlvang Wongsa - Derat at the mouth of the large canal Klawng Bang Looang.

My father (Dan Freeman Bradley) was born in Bangkok. His mother was one of the early women graduates of Oberlin College 1843 and my grandfather's second wife."

A commodore about whom many will have fond memories. Your editor particularly remembers a personal tour that Dan gave her of his cottage and his pride in taking part in its construction.

MINUTES OF O.T.Y.C. ANNUAL MEETING OF JULY 21, 1984

The meeting was called to order by Commodore Fred Schwarze at 10:00 A.M. at the Omena-Traverse Yacht Club. In the absence of the secretary, Carolin Renz was appointed "acting secretary" for the day.

There were no proxies. A quorum was present.

Upon motion by Mrs. Vail, seconded by Mr. Oberndorf, the 1983 OTYC Annual Meeting minutes were approved.

D.J. St. John gave the treasurer's report, indicating a current approximate balance of \$7,300. Taxes are estimated to be about \$1,650.00; insurance \$1200.00. Major repair is needed for the front porch of the club and the Youth Program will be supplemented by club funds. A Treasurer's Report covering the period January 1 to July 15, 1984 was available for members present and a copy of this is attached to the official minutes. It was pointed out that the 1983 Treasurer's Report was printed in the June Breeze had reversed the salaries for the tennis and sailing instructors. Upon motion by Harold Grossman, the Treasurer's Report was accepted.

OLD BUSINESS:

Commodore Schwarze called for committee reports.

House & Grounds:

Bob Harper reported that much work had been accomplished at the club this year. All the electrical outlets are now grounded; new stairs have been installed leading up to the tennis court and also a new bulletin board at the base of these steps; the navigation lights were rewired; a renovation of the front porch is under consideration and the kitchen is being looked at with

the thought of some remodeling. Fred Schwarze added that much of the porch substructure is rotted and that the board is getting bids on fixing this. He added that the railing on the porch may not meet code and that the board is looking at the kitchen.

Tennis:

Jonnie Hodgson reported the tennis teaching program had had three or four students the first week, this week there were 10 enrolled. The court is in good shape and the lines have been freshly painted. The fees for the Round Robins held on Fridays have been dropped and Jonnie expressed appreciation to Bill Renz, tennis instructor, for donating his time for these Friday afternoons.

Sailing:

M.H. Ray, reporting for Kevin Ray, stated that seven students were currently enrolled in sailing classes, five in Windsurfing classes. Sixteen had participated in the trip to the sand dunes, 20 had gone canoeing, both part of the Wednesday special activities. She further reported that a rescue mission had recently taken place on the lake. The yacht club boat was ready to go and Kevin was available to respond to the emergency. The club owes a debt of gratitude to both Kevin and John Ray who literally saved some persons in distress, thanks to their quick action and the fact that the boat was properly ready. A suggestion was made to train others to operate the OTYC boat so that they would be available for future emergencies. Two sailing race days have been held with a total of seven different people racing and six races held.

Waterfront:

Vicki Sova reported that all the yacht club slips have been rented for the summer, yielding a rental fee total of \$810.00 per year for the club. Annual rental fees are determined by the water level available, i.e. if the water is deep in any given slip, a larger boat can be moored than when the water is shallow. When asked who gets preference in renting slips, Vicki replied that those who have rented a slip one year have the right to renew for the following year. At present there is just one name on the waiting list for a slip rental. (Apparently rank means nothing because it is the Commodore whose name is on the waiting list.)


