


Theta Burke's poetry and outlook on life added a new dimension to the potluck programs and the Fashion Show and Youth Cookout

#### From Gennie Grossman . . .





Many of you are aware that the Historical Writers Group has published A HISTORY OF LEELANAU TOWNSHIP. On occasion, we will print excerpts pertaining to Omena.

In this edition of the BREEZE, we start with the derivation of the name, Omena:

# Omena

The arrival of the Rev. Peter Dougherty, in 1852, marks the beginning of Omena's history. From Old Mission, he moved across the Bay to establish, for the Indians, a New Mission on the high land known today as Omena Heights. Omena Point is still sometimes called New Mission Point.

Rev. Dougherty referred to the Mission church as the Grove Hill New Mission church; and Rev. George Smith, in his diary, called Dougherty's Presbyterian establishment Grove Hill Seminary, but the Indians apparently gave Omena its official name. Ruth Craker, granddaughter of George A. Craker who arrived in 1852 with the Doughertys, tells us in her book, First Protestant Mission in The Grand Traverse Region: "Many times the Indians came to Dougherty to ask a question or give him an interesting bit of information about something, and he invariably replied in the Indian tongue, 'O-me-nah', meaning 'Is it so?'" The Indians were amused with his answer and gave him the nickname O-me-nah. Miss Craker says that the Indians thought their name for Dougherty would be an appropriate name for the New
