THE J.T. WING

OWNER: J.T. Wing and Co., Detroit, MI
BUILT BY: Beazley Brothers, Weymouth, Nova Scotia
DATE: 1919

DIMENSIONS: 152 feet long by 33 feet 5 inches wide by 14 feet draft.

The person for whom this schooner was named was Jefferson Thurber Wing-born in Monroe, MI on June 4th, 1860. He graduated from the Michigan Military Academy, and moved to Detroit in 1881. In 1886, he established the J.T. Wing Company, a firm which engaged in the supply of castings, bearing materials and various industrial and ship chandlery items and hardware. The schooner was used to transport these supplies to various ports throughout the Great Lakes. Mr. Wing died in Detroit on December 1, 1932.

The J.T. Wing was a three masted schooner, also known as a tern. It sailed the Great Lakes from 1919 until 1938, when it was deeded to the Detroit area Sea Scouts, as a training ship. However, this arrangement did not work out, and the J.T. Wing was moved to Marine City, Michigan, where it lay idle until 1942. At this time, it was towed back to Detroit and buried on land at Belle Isle where it was used as a marine museum. It was finally burned down to make room for the present Dossin Great Lakes Museum, which was built in 1960.

This model of the J.T. Wing was constructed from a set of blueprints obtained from the Smithsonian Museum, by Edward Clements of Saginaw, Michigan.

WATERFRONT POLICY

As approved by the Board of Directors, July, 1987.

- Once a Club member, in good standing, has rented a boat slip, he or she may continue to rent said slip providing membership dues and slip rental fees are both paid, to the Treasurer, by April 1st, for the upcoming season.
- 2. If dues and slip rental fees are not paid, in full, by April 1st, the slip shall be declared vacated and available
- 3. Vacated slips shall be awarded to the most senior eligible adult member applicant requesting use of the available slip.
- 4. Seniority for renting available slips shall be based on the following point system: one point for each year of continuous adult membership plus 1/2 point for each year of continuous youth membership-providing there has been no lapse of dues being paid in either case.
- 5. Boats, in rental slips at OTYC must be registered in the name of the applicant. The owner must certify that he/ she is carrying public liability and property damage insurance on his/her boat, and that it shall be in force during the time that the boat is on Club premises.
- 6. Each slip renter must certify the Omena Traverse Yacht Club as an additional named insured on said liability insurance policy.
- 7. The above rules will also include members who lease vacant slips during the boating season.
- 8, 1987 season slip rental fees will be increased by 15%. It was understood that the Waterfront Committee would make future recommendations concerning fees, in future seasons, after investigating fees and percentage of increases at local marinas in the area.
- 9. The tying of Martineau's boat to the breakwall will be in effect for the 1987 season only-for \$125.00. He will be required to abide by the rules stated above regarding insurance credentials. (None of the slip rental. seniority policies apply to this "once only" breakwall area rental).
- Future breakwall rentals must be requested and permitted annually with waterfront policy (1987) governing where applicable.
- 11. The OTYC Committee boat will remain moored in the shallowest boat slip for the 1987 season. In future years, if need arises, other places, along the shore, will be investigated for its mooring.

*** The Board agreed that the ease and safety of entering and leaving said boat from the dock and catwalk area was more important than the additional rental fee that the 5th slip might bring in

- 12. All boats must be tied properly with good, new lines. The Waterfront Chairperson and the Commodore shall be instructed to check the safety of breakwall moorings and make appropriate recommendations to the owner of boat in that slip.
- 13. Whenever the launching ramp is used the approving OTYC member, in good standing, must be present during the activity.
- 14. Rules of safety on the dock, etc. are included in the Statement of Policy for the Omena Traverse Yacht Club.

Members are invited to keep their small boats pulled up on the sand at the Sunfish Cove, at no charge. There is no charge for launching or hauling out boats. Rental fees are charged for dock space; reservations to be made through the Waterfront Committee.

The Yacht Club boat is not to be operated by or boarded by anyone who is not specifically authorized to do so. Boating: All persons participating in Club-sanctioned boating activities are required to wear Coast Guard approved life vests.

All sailors and other boat operators should be familiar with and adhere to the Rules of Boating Safety and the laws of the State of Michigan,

Tennis: The Tennis Court is maintained by OTYC members for the exclusive use of members and their bona-fide quests (when playing with the host member).

Players should wear appropriate attire and observe the standard rules of tennis etiquette.

Demand for court time varies from month to month and year to year; therefore players should consult the Tennis Board at the foot of the stairs for current policy regarding reservation of court time.

Youth and Adult Activities Program: The Club sponsors a program of instruction and other activities for young people and adults. Children under the age of eight years are welcome to participate only if accompanied by a parent. Parents of young people (ages 8 through 17) participating in Club activities are expected to assist with

transportation and chaperonage when necessary,

Playground: This area is maintained for the exclusive enjoyment of our children under the age of 12. Older children should not be on the playground unless acting in the capacity of baby-sitter.

Private Parties: Members desiring to hold private parties or other events on Club property may do so only with the approval of the Board of Directors and upon such terms as the Board may deem appropriate.

STATEMENT OF POLICY As approved by the Board of Directors on July 18, 1981

Each member of the OTYC shares equally in the ownership of and responsibility for the Club and its facilities. Our mutual comfort, enjoyment, and safety require observance of the following policies regarding use of the Club.

General: The Club does not have full time hired maintenance help—therefore it is necessary for each one of us to clean up after ourselves. This includes beverage cans, cigaret butts, and all other litter, whether inside the clubhouse, at the tennis court, or around the yard and beach.

Dogs and other pets are not allowed on OTYC property, unless confined to the inside of a car.

Any child under the age of 8 years must be accompanied by a parent or authorized baby-sitter over the age of

12 when on Club property or participating in Club activities.

Consumption of alcoholic beverages on Club property is limited to persons of legal drinking age attending Club sponsored events. (Until recently, the By-Laws of OTYC strictly prohibited all use of alcohol on Club property. Our current By-Laws state that the Board of Directors may approve such use on an annual basis only.)

Potlucks: The member is to bring a main dish, salad, or vegetable dish in ample quantity to serve the number of persons in the member's party PLUS EIGHT OTHERS.

Appropriate attire for adults and children attending potlucks is "neat-but-casual". Shoes and shirts are

required.

Members and guests are welcome at all potlucks, and are requested to sign-up on the sheet provided as early as possible, so that the Entertainment Committee can plan accordingly. In order to help defray the cost of coffee, dessert, and hired help the Committee may from time to time charge a nominal fee as it deems necessary.

Happy Hour (the hour preceding supper) is a B.Y.O.B. affair. Ice and mixes will be available at the bar, as well

as refreshments for children.

Waterfront: All swimming is to be done from the "south beach"—not in the Sunfish Cove or Dock areas. OTYC does not provide supervision for swimmers.

Boats and boating equipment are private property and are not be borrowed or boarded without owner permission. Running and/or rough-housing on the Club dock are prohibited in the interest of safety.

The minutes of the 1986 Annual Meeting were accepted as printed in the Breeze.

Bill Sandt gave the Treasurer's Report and passed around a written statement, as filed with the Secretary's Minutes. It was moved and seconded by Mary Smith and Bob Martineau to accept the report, Motion carried.

Old Business

The dock policy was reported by the Waterfront Committee (see July 11 Board Meeting Minutes). Five hundred dollars have been pledged towards the purchase of the J.T. Wing model boat.

Committees

Social: (submitted by Mary Smith, Chairperson)

"The 1986 season opened with a meeting of the Social Committee at Mary Smith's house to plan the program for the year. The Social Chairman is responsible for the dinner affairs but the programs following the dinner are the responsibility of a different chairman.

The following is a summary of the activities of the season.

- 1. A write-up of the duties of the pot-luck hostesses and help was prepared and is available for distribution. This includes the weekly chairman, the monthly chairman and the paid clean-up help.
- 2. It was decided the catered dinners should carry an extra one dollar fee to cover decorations and incidentals.
- 3. The Opening Dinner was catered by the Beech Tree and 139 people attended. Mary Smith was the chairman for the dinner.
- 4. There were nine potluck dinners during the season. The use of monthly chairmen to order supplies and pay the help—greatly reduces the work of the social chairman and spreads the responsibilities among more people. Therefore, we will continue this procedure.
- 5. The Commodore's Reception and Founders' Fund dinner was chaired by Kathy Bosco and about 114 people attended. The canapes were provided by the social committee members and the dinner was catered by the Beech Tree.
- 6. The Square Dance was chaired by Debbie Love and Martine Moore with Don Day as the caller. Sixty-seven enthusiastic people attended.
- 7. The 1987 season began with a 4th of July chicken dinner arranged by Connie Martineau and Mary Smith. One hundred fifteen members attended.
- 8. The July social committee meeting was held at Mary Smith's to plan the July events. This year there will be an August social committee meeting at Pat Bailey's.

There is not a financial report included because the funds are turned over to the treasurer as well as expenses at the Country Store."

House and Grounds: (submitted by Bob Harper, Chairperson)

"The activities of the Committee sine the 1986 Annual Meeting include the following:

The autumn closing of the Clubhouse included shut-off and draining of the water system.

Repair of the tennis net which was handled by the generous help of Jack Sarvis.

Overhaul of the water pump during the winter, made necessary because of worm bearings.

With the cooperation of the Commodore and the Board, a new caretaker was hired for the 1987 season. He is Walter Wien, and is well qualified.

The caretaker replaced a lower sash on a second floor window.

The entire south side of the Clubhouse, the floors of both upper and lower porches and the railings of the first floor porch have been painted. This included new glazing on most of the south-side windows and replacement of cracked and broken panes.

The beach and launching ramp were cleared of stones, brush and driftwood. Two and one-half truck loads

of debris were hauled away.

The caretaker and his wife, Janis, cleaned the entire interior and porches and arranged the furniture for Club opening. In addition, the hedges were trimmed, the lawn mowed, and the driveway sides sprayed to kill poison ivy. The lawn and hedges were fertilized.

Toilets in both rest-rooms have been repaired.

An exterminator has been scheduled to treat the exterior of the building and surrounding ground for spiders and ants. Weather permitting, this will be done in the morning of July 23rd.

An estimate of cost for the installation of two overhead fans has been received for consideration by the

Board.

The Chairman wishes to acknowledge and thank the Committee members for their help and cooperation.

Youth Activities: (submitted by Bob Love, Chairperson, Kevin Ray and Mark Spitz-Nagel) There has been a total of 10 children in the program (8 each week).

Gross receipts: Week 1: \$135, Week 2: \$140

Wednesday activities: Week 1: Sand Dunes-11 people; Week 2: Put-Put Golf-15 people. Each trip has involved a few younger (under the minimum age) people.

Future activities: July 22: Youth chili dinner, August 5: Mackinac Island (this involves the entire Club-a preliminary sign-up will be passed around next Wednesday). Possible future activities: Waterslide, campout (specific tennis and sailing reports follow.)

Iennis: (Mark Spitz-Nagel)

"The current OTYC Tennis Program has been rolling quite successfully; the amount of people involved in lessons has remained the same since last summer at this point in the program. There has been a loss of a few people this year but also a significant gain. Right now the program includes 3 Beginners, 4 Intermediates, 1 Advanced, 1 Adult.

The Round Robins seem to have slightly lost some of the popularity I believe they have had in the past, the turnouts included 2 people last week and only 1 this week. I don't know if this is due to a dearth of enthusiasm or time. Regardless, I'm wondering if some small tournaments within the Club might be a better alternative.

At any rate, the program is certainly looking up this summer. I'm counting on the rest of the summer being as

great as it has so far."

Sailing: (Kevin Ray)

"Races: we have had three days of possible races. Since only one boat was available each time (we need a minimum of three), there have been no races.

It is assumed that there will be races in weeks to come as more people who have raced in the past will be here. Classes. There has been a total of seven people in the classes (five each week).

Only beginner and intermediate classes have been held. An advanced class is available at 11:00 and an adult class at 12:00.

Waterfront Committee Report: (submitted by John Harris, Chr.)

"At the end of last summer, the Waterfront Committee sent out questionnaires to all OTYC members concerning the issue of boat slip rentals, etc. Thirty-two responses were received in answer to this questionnaire. Seven people requested season rentals, one response said "maybe" and one response was for a "partial" rental. The votes were tallied and comments summarized. A questionnaire (based on the member's votes and comments) was sent to all waterfront Committee members. Again votes were tallied and all comments noted.

At the first OTYC Board meeting of 1987, Board members were presented with copies of the questionnaires, tally of votes and comments received. This allowed time for review and consideration of the results. A special Board meeting was held on Saturday, July 11, 1987, at which time the various aspects of slip rentals, comments from members etc. were discussed and analyzed.

Presently, all slips are rented for the 1987 season, including the breakwall "slip", which will be rented annually as approved by the Board. Fees will be increased by 15% for the 1987 season. The possibility of finding an area for boat trailer storage will be studied. A statement of policy, concerning the rental of slips, will be

formulated from decisions made by the Board."

John Harris requested that the entire policy be printed in the Breeze.

Membership Report: (submitted by John Ray, Chr.)

"New members: Samuel and Mary Cone (recommended by Mary Smith and Jonnie Hodgson).

Guest members: Ole and Joan Kiersey and Kim (daughter-Jr.).

Total membership units: 110"

At OTYC functions, it was requested that people applying for membership be introduced as such and not as prospective members, thereby not assuming that they will automatically be members.

Nominating Report: (submitted by John Ray, Chr.)

"Each of the Board members whose terms expire on 9/15/87 have agreed to serve for another term (to 9/15/90). They are Mary Helen Ray, William Renz and Robert Bailey."

Special Activities: (submitted by Jonnie Hodgson, Chr.)

"The Special Activities Committee has planned the following activities that have taken place or will take place after pot lucks on Wednesday during July and August.

Breeze: The editors were not present, but their hard work and efforts were acknowledged and appreciated.

Founder's Fund: (submitted by John Roth, Chr.)

The balance in the Fund as of 12/31/86 was \$5,529.26. No donations have been received for the last two years. Caroline Renz was selected as a new Director along with John Roth. The reasons for establishing the Fund were described by John Roth and Austin Jones.

New Business:

The 40th year celebration committee will be headed by Rat and Bill Renz, Mary Helen and John Ray for the year 1988

Kathy Bosco and Connie Martineau are researching the purchase and installation of ceiling fans. Kathy requested screens to be placed in the snack bar windows.

It was moved and seconded by Jonnie Hodgson and John Harris that the Secretary cast a unanimous ballot for the slate of officers presented by the Nominating Committee for 1987-90.

The meeting was adjourned at 11:05 a.m.

Annual Meeting August 10, 1950

In order that the entire membership of the Omena-Traverse Yacht Club, those who have joined recently, as well as those who were members at the beginning, may know what has been done and how accomplished, we submit the following brief summary:

The Club was organized early in July 1948, through the initiative

and tireless effort of Gus Rogers, assisted by a few interested helpers.

Articles of Incorporation were filed with the Michigan Corporation and Securities Commission August 9, 1948, and a Charter was issued in the name of the Omena-Traverse Yacht Club, Incorporated.

At the time the Club was formed, a two year lease on the Club's present property was secured from Mr. H. M. Carmichael at an annual rental of \$1.00. The lease carried an option to purchase the property any time within the period of the lease for the sum of \$2,000.00.

Revenue of the Club for 1948 amounted to \$745.82, derived from dues, initiation fees, proceeds from special benefit parties, Snack Bar, and some fall contributions. For cleaning up the grounds, putting the building in usable condition, improving the road-ways, together with some minor repairs and improvements, we spent in 1948, \$441.99, leaving a balance of \$303.83. This was made possible largely by our member, Frank Kalchik, who gave generously of his time and use of equipment without charge.

Early in the vacation season of 1949, a campaign was started to raise funds for the purchase of this property. The result of the fund. raising campaign was as follows: 14 members contributed \$100.00 each; 6 members, \$50.00 each; 4 members, \$25.00 each; 3 members, \$10.00 each; also, one \$15.00 and one \$5.00 subscription from non-members.

At the annual meeting in 1949, Mr. Carmichael very generously reduced the purchase price \$100.00. With this reduction, and the funds secured by our campaign, together with a small amount from our general fund, the purchase of the property was consummated. A deed to the property was delivered at this meeting to your property officers.

Extended coverage insurance in the amount of \$7,500.00 is carried

on your property. We are, also, protected with Liability Insurance.

At this same meeting, a lease for 5 vears was secured from Mr. Carmichael on the two lots adjoining our property, at an annual rental of \$1.00. Aportion of these two lots has been converted into a very necessary parking lot. Space is also available for a tennis court, which will be constructed in the near future. Materials and cost of construction of a tennis court have already been generously donated by Mr. Fred Schaefen.

Also during 1949, our new dock was constructed, and shore improvements made under the able supervision of member, Paul Hill, who also contributed a lot of manual labor to give us very creditable yachting facilities. Paul has also been tireless in his efforts in managing our racing events, which have been most successful and afforded great pleasure to the participants as well as to the spectators.

Expenditures during 1949, including the purchase of the property, amounted to \$3,142.90, leaving a balance in the treasury of \$153.51.

We closed the 1949 season with a membership of 62.

At the first meeting of your directors in 1950, it was decided to proceed with the very necessary improvement of installing restrooms. These rest-rooms; as you. know, are now completed. Your Board of Directors proceeded with this improvement largely on faith, that is faith in our members. We felt that the members, realizing the desirability of this improvement, would readily supply the funds necessary to cover the cost. Our solicitors, to date, have contacted a limited number of members and report contributions amounting to \$340,00. All the bills for this improvement are not yet in, however, we know contributions thus far are considerably short of the total cost. Your directors, never-the-less, still have faith.

At this first meeting in 1950, a lease for two years was secured from Mr. Carmichael on his boat slip, at an annual rent of \$1.00. This added facility is available to members and quests alike.

The next major improvements we plan to make are the painting of the Club House building, and overhauling the lighting system. We hope we can proceed with these necessary improvements at an early date.

The renewed interest that is manifest these past weeks, both in yachting and social activities, convince us that in a very short time we shall have a Yacht Club and a Community Social Center of which we all can be justly proud.

A report such as this would be incomplete if attention were not invited to the very special services rendered by some of our members.

Mary Foltz, for instance, has rendered so many different services it is impossible to enumerate them all. As Secretary of the Board, and Chairman of the House and Grounds Committee she has given unstintedly of her time, skill and effort. She designed the restrooms, decorated the lounge, painted the Snack Bar, did carpentry work, supplied great quantities of material from her own stock, and paid for a lot of other things with her own funds.

Then there is Mrs. George Smith, Chairman of our Social Committee, who has given us many pleasant times here at the Club House, The proof of an able Chairman is the support and cooperation received from the membership; these Mrs. Smith has had in large measure, especially from Mrs. Kitty Smith, Mrs. Lestra Saxon, The Newman Sisters, Mrs. Griffin, and others. Mrs. Smith always has the Club House clean and in order for all social functions, and order restored after the party is over.

Again, there is Carolin Smith and Mary Helen Ayars. How could the Club function without these two efficient and willing workers? They are always ready to perform any

service asked of them. They are our very dependable solicitors, ticket sellers and errand runners.

To all who have contributed financially, with manual labor, with advice, or in any other way, your directors and members are deeply grateful.



FOUNDER'S FUND

P.S. What follows is a reprint of a sheet that answers all the questions about the Fund. It was written back in 1975 and appeared in the December issue of the Breeze in 1975.

THE OTYC FOUNDERS FUND

OMENA, MI 49674

November 18, 1975

This Fund has been established in honor of those who participated in the founding of our Club.

Purpose: To create an Endowment Fund to assure stability to the Club's long-range planning, and to allow donors to specify the uses to which their gifts shall be used.

Organization: The Directors of the Club shall direct the policy of the Fund, but delegate the management of the Monies to a Committee of Trustees, consisting of the Commodore and Treasurer of the Club, plus three members of the Club, not Board Members, appointed by the Directors.

The duties of the Trustees shall be to manage the Principle of the Fund, to annually transfer the Interest Income of the Fund to the Directors, and to conduct an annual solicitation for gifts.

The Initial Trustees and their terms of office are: Dan T. Bradley, President '75-'76; John E. Roth, Secretary and Treasurer '75-'78; Leona Milroy, Member '75-'77; Austin Jones, Commodore '75-'76; Vernon Keye, Treasurer '75-'76.

Allocation of Gifts: Donors shall designate that their gifts be applied to one of the following accounts: 1) Člubhouse Capital and Improvements, 2) Sailing and Waterfront-Capital and Improvements, 3) Tennis Facilities-Capital and Improvements, 4) Donor leaves allocation to the Club Directors.

All funds to be held as Capital, indefinitely, UNLESS the donor gives permission in writing that the gift may be removed from the Capital of the Fund, by the Directors, at their option, and expended for the accounts specified by the Donor.

All gifts should be made out to "OTYC FOUNDERS FUND" and mailed to: John Roth, Treasurer, 3534 Deep Woods Lane, Cincinnati, OH 45208 and should specify the account to which you wish the gift applied, and the Withdrawal Option if desired, as indicated above.

This Fund should appeal to the Members as: a) Building a solid Endowment Base for the future of the Club, and b) Allowing Donors to designate their gifts for the specific areas of Club activity which they feel are most important.

It will also enable the Directors to plan improvement programs in line with the membership's wishes, and thereby eliminate many of the problems we have had in the past.

Turge all members to seriously consider making a gift . to this Fund, to build up our financial structure and to indicate the areas of improvement they feel most desirable.

A very welcome Initial Gift of \$100 has been made by Miss Clemewell Lay, and several memorials have also been received.

With the exception of the Initial Gift, the amounts of individual gifts will NOT be published.
