

As the out-going chairman, I would suggest the following major projects be given consideration:

- 1. Repair or replace the upper porch floor.
- 2. Paint the east, north and west sides of the Clubhouse. The east end is in very poor condition.
- 3. Replace the exiting metal shed with a larger, well-built structure.
- 4. Consider the installation of a water system that would pump water from the bay for watering the grounds. This is suggested since the present well pump is old and the well-water should be conserved for the Clubhouse use.

I want to acknowledge and thank the members of the House & Grounds committee for their advice and assistance during my tenure as Chairman, particularly the cheerful and capable help given by Harold Grossman and Phil DiLoreto.

### Social Committee (1987 Season): (submitted by Mary Smith, chairperson)

The 1987 season opened with the 4th of July Dinner. The Social Committee met the following Tuesday, July 7th, at Mary Smith's house to plan the program for the year. At the meeting, programs for after the Pot-Lucks were discussed, as well as the next Opening Dinner.

The following is a summary of the activities of the season:

- 1. It was decided that the catered dinner should continue to carry an extra one dollar fee to cover decorations and incidentals.
- 2. The Opening Dinner was chaired by Connie Martineau and Mary Smith. One hundred fifteen people attended. The food was ordered by Kentucky Fried Chicken, The Hose House Deli, with desserts from Chef Pierre.
- 3. There were nine potluck dinners during the season. The use of a monthly chair to order supplies and pay the help greatly reduces the work of the social chairman and spreads the responsibilities among more people. Therefore, this procedure was continued. Mary Woolford did July and Rat Renz did August.
- 4. The Commodore's Reception and Founders' Fund dinner was chaired by Rat Renz and about 114 people attended. The canapes were provided by the Social Committee members and the dinner was catered by Simply Appetizing.
- 5. The Square Dance was chaired by Betsy Ehrhardt, Betty Gregory, and Nancy Sandt, with Don Day as the caller. Attendance was poor. The event conflicted with the World's Largest Cherry Pie event and this was its third year also. It was decided that the Square Dance would not be held next (1989) year.
- 6. The Social Committee met two times this year in July at Mary Smith's and in August at Pat Bailey's - to allow more people to attend. That was successful, and about 12 people attended each meeting.






are almost a daily ritual. It makes the National Episcopal Church, me happy that I'm retired.
