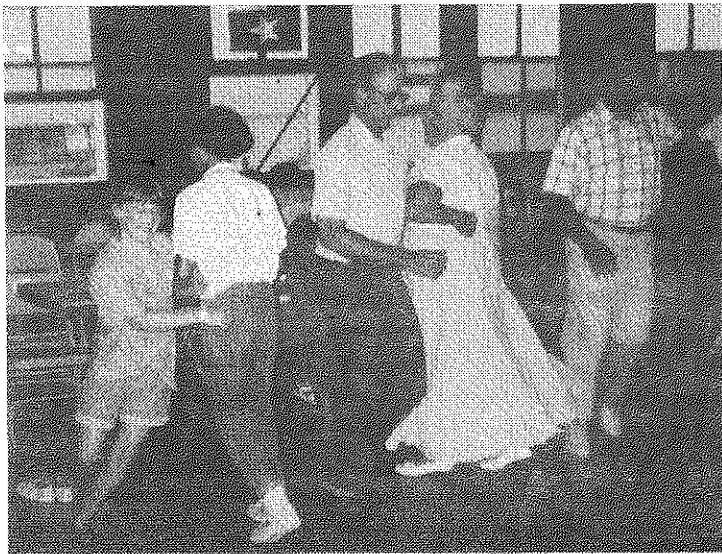

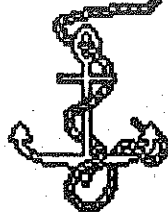

## Margaret T. ("Peg") Morse

Margaret T. ("Peg") Morse, widow of Robert L. Morse, died November 5, 1990, following a fall and a broken hip in October. She was 90 years old. Memorial services were held in Cleveland, Ohio, with all the family present.

Mrs. Morse was born in Oskaloosa, Iowa, on April 1, 1900. She attended Smith College and graduated from Northwestern University in 1923. In 1924 she married Robert L. Morse, past Commodore of OTYC, and they lived in Cleveland until their deaths.

Mrs. Morse was a charter member of OTYC and a staunch supporter. She was interested in flowers and painting and she completed her last painting two months before her death.

Mrs. Morse is survived by two children, Jane M. Saxton and Thomas T. Morse, five grandchildren and four great-grandchildren.

1947, she was a mail carrier and also transferred mail between the Post Office and train on its way to and from Northport.

After World War II, Mrs. Smith was a part-time postal clerk until her appointment as postmaster in September, 1967. She was Omena's postmaster for more than 13 years until retiring as of January 17, 1981.

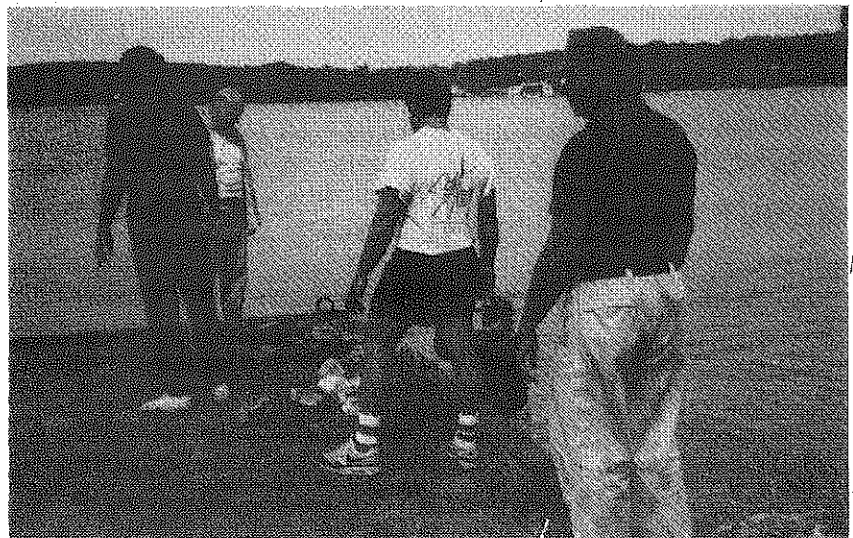

## Geneva Smith

A memorial service was held for Geneva Ellen Smith, a lifelong Omena resident and a long-time Omena postmaster, who died February 19 at Leelanau Memorial Hospital following a lengthy illness. She was 80.

A graduate of Western Michigan University, Mrs. Smith taught school for eight years at Leland and Bass Lake and on North Manitou Island. She was a member of the Suttons Bay Church, the Order of the Eastern Star, Chapter 147, and the Omena Club 21, and had been a member of the Leelanau Township Cemetery Committee.

Mrs. Smith began her Post Office career, which spanned six decades, as a summer employee at Omena in 1937. From 1944 to

## FRIENDS REMEMBERED



### MEMORIES FROM EARLY OTYC YEARS

My mother, Leona Milroy, was affiliated with the Yacht Club beginning in the early 1950's. Mary Foltz was instrumental in getting my mother to join. Gus Rogers, George Smith, Paul Hill, Dave Devore, Humphrey Jackson, Joe Alcorn, Stewart Ayars -- all the Commodores, Vice-Commodores and Rear Commodores!

During the years there were so many parties, all with different themes. The paper party -- my mother and aunt spent two days constructing outfits for my cousin and me.

She had cherries made of paper all over a skirt and blouse sewn on and I had a skirt and blouse made entirely of newspaper. They worked so hard on those outfits -- I can still see them sewing. The circus party, the Greenwich Village Party -- I remember my mother singing a French song "Madelon" at one of the parties, wearing long gloves and a large hat with a red dress and ending the song with "oo-la-la."

We had the penguin fleet then and Mother would sit on the porch of the Club on race day watching us and visiting all afternoon. They had lots of races then -- Mother was enlisted once when a crew member failed to show up. The boat was Mary Foltz's wooden "Lightning" with Crampton Finn as the Skipper. Crampton had to use non-nautical language to tell her what to do -- "Pull on that rope on your left," etc. It was a thrilling time for her that she would tell about often afterward -- and they won the race!

She would also tell about how Dr. Andy Renz came over to the house and persuaded her to take on the chairmanship of the opening dinner. In those days we had home-cooked turkeys. Mother said she didn't know how he did it but she had a great time and it turned out absolutely great.

So many years -- so many memories -- so many people -- through all the years she maintained her membership in the Club, valuing the friends she made and the fun times each summer. It seemed as if she would always be there laughing and bubbling -- full of life and sparkle -- telling about her trips around the world and coming to potluck with her brother, Harold Boudreau, in recent years.

Her stroke in October of 1989 slowed her down but those who saw her at the August potluck this past summer could see she still had lots of nerve when she got up and introduced our table. She didn't miss a beat -- 89 years young.

## TREASURER'S REPORT SPRING, 1991

Dear Commodore,

The major reason for the expenses exceeding our receipts in 1990 has been our club maintenance costs which this last year involved protecting our dock structure from further erosion. As can be seen from the seven year compilation included in this report, in five of these seven years we had extraordinary expenses in connection with club maintenance. As the club facilities further mature, this may be a continuing large expense in most years.


With the exception of this expense, I believe that we had a very good financial year. Our activities committees not only presented an outstanding program but provided us with an unexpected pleasant bonus of breaking into the profit column.

Although the cost of the "Breeze" has increased, this is due in large measure to the increased number of pages and quality of printing in our recent editions. If we view the "Breeze" as a souvenir of the good times spent in Omena, the expense can be justified and should be able to permit an increase in the subscription costs.

Both our taxes and insurance have increased in proportion significantly more than our membership dues in the last seven years. I also feel that our insurance is inadequate should we be forced to replace our club facilities with an equivalent structure, given today's construction costs.

Bottom line is that we are currently in good financial shape, but that we need to look to the future and prepare for increased expenditures in order to maintain the financial health of the club.


