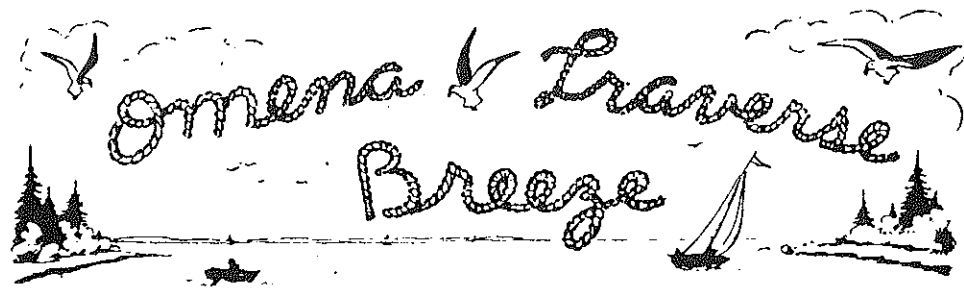
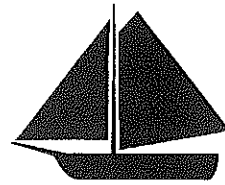

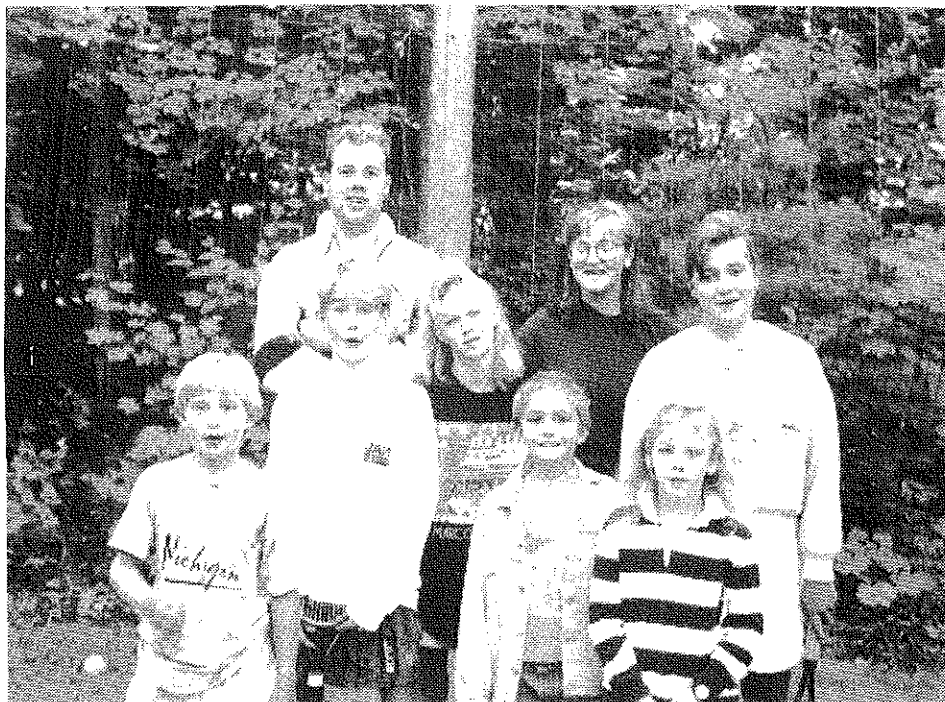
## BOARD MEETING NOTICES

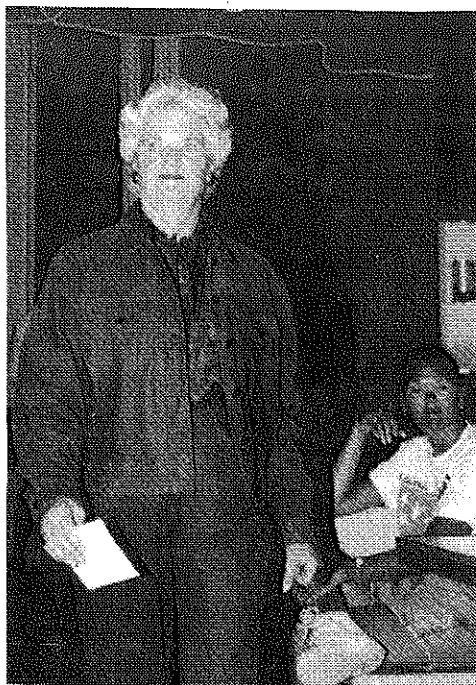

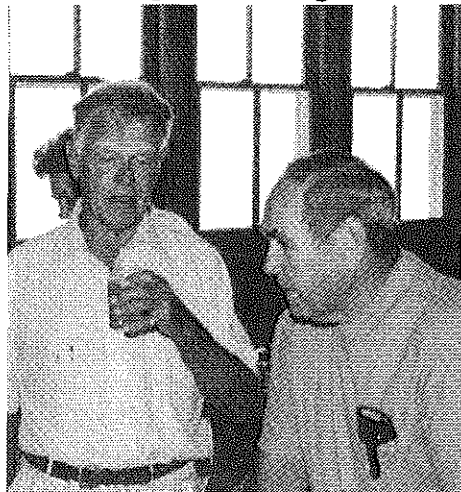

## Recipes from Michigan (Submitted by Mary Smith)

### Power Bars

A great pick-me-up any time of day.

3/4 cup	light margarine
2 cups	firmly packed light brown sugar
2 cups	all-purpose flour
2 cups	old-fashion or quick-cooking oats, uncooked
2 tsp	baking soda
1 can	(21 ounces) cherry filling and topping
2 tbs	granulated sugar
1 tbs + 1 tsp	cornstarch
1/2 tsp	almond extract

In a mixing bowl with an electric mixer, beat butter and brown sugar until light and fluffy. Combine flour, oats and baking soda. Add flour mixture to sugar mixture; mix on low speed until crumbly.

Spread half of the oat mixture into the bottom of a 13x9x2 inch baking pan that has been coated with non-stick spray. Press down to make a firm layer.

In an electric blender or food processor, puree cherry filling until smooth. Pour pureed cherry filling into a medium saucepan. Combine granulated sugar and cornstarch; stir into cherry filling. Cook, stirring constantly, over low heat until mixture is thick and bubbly. Pour cherry mixture over oat layer in pan and spread evenly. Sprinkle remaining oat mixture evenly over cherry mixture.

Bake in a preheated 325 degree oven 45 minutes, or until golden brown. Allow to cool before cutting into bars.

Makes 24 bars.

## CHERRY CHICKEN FAJITAS

A south-of-the-border treat with a tangy twist.

2 cups	individually quick frozen tart cherries
1 cup	frozen corn
2-1/2 cups	shredded lettuce
1 pound	boneless, skinless chicken breast
1 cup	shredded light Cheddar cheese
1/3 cup	sour cream
8	flour tortillas

Thaw cherries and corn, drain well.

Cut chicken into strips; saute in a large skillet coated with non-stick spray.

In another skillet coated with non-stick spray, cook cherries and corn until hot, draining well after cooking.

For each fajita, spread 2 teaspoons sour cream on one-half of each tortilla. Divide lettuce, cheese, chicken and cherry-corn mixture into eights. Put a portion of each on each tortilla. Roll tortilla into a cylinder. Serve immediately.

Makes 8 servings.

Notes: Fajita may be reheated in microwave on HIGH (100% power) for 1 minute.
