

AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE OMENA-TRAVERSE YACHT CLUB

The Articles of Incorporation of the OMENA-TRAVERSE YACHT CLUB, a non-profit corporation existing under the laws of the State of Michigan, are hereby amended as follows:

- 1. The present ARTICLE X is renumbered ARTICLE XI.
- 2. The following new ARTICLE X is added:

ARTICLE X

No "volunteer director" (as defined in the Michigan Nonprofit Corporation Act) of the corporation shall be personally liable to the corporation or to its members for monetary damages for a breach of the director's fiduciary duty to the corporation or to its members, so long as such breach did not also constitute:

- (a) A breach of the director's duty of loyalty to the corporation or to its members,
- (b) An act or a failure to act not in good faith, or intentional misconduct, or a knowing violation of law,
- (c) An act in violation of section 551(1) of the Michigan Nonprofit Corporation Act,
- (d) A transaction from which the director derived an improper personal benefit,
- (e) An act or omission which occurred before the effective date of the adoption of this Article X to the amended Articles of Incorporation, or
- (f) An act or omission that was grossly negligent.

Then from there to Sanibel with the Rays for a couple of nights. Linda Ray McKenzie was my roommate!






Bill and Mary do much volunteer and community work. The whole family likes to go snow skiing.

Mary Louise was a longtime active and supportive member of O.T.Y.C.. She was particularly interested in the Youth and Tennis programs. She would have been 95 in July.


She is survived by her daughter, Caroline Oberndorf; son, David Gleason; seven grandchildren and five great grandchildren.

BOATERS ARE REMINDED OF SAFE OPERATING REGULATIONS:

- Powered watercraft must always yield right-of-way to unpowered craft - sailboats, rowboats, canoes, paddle boats, etc. - or to any watercraft on their starboard (right) side.
- Powered watercraft may only approach within 100 feet of a dock, raft, anchored boat or swimmer at no wake speed.
- Jet-skis (personal watercraft) are considered to be powered watercraft and must obey all regulations applying thereto.
- Any watercraft towing a water skier, watersled or tube must have a competent rear-facing observer on board, in addition to the driver.
- Any operator of a powered watercraft under the age of 16 must have a competent operator on board or show evidence of having passed an approved marine training course.
- All high-speed boating must be done by going counter-clockwise around the lake. This includes waterskiing, jet skis, water sleds, etc.
