Minutes of Annual Meeting of the Members of the Omena Traverse Yacht Club, July 18, 2009

The Annual Meeting of the OTYC was held July 18, 2009 and attended by 75 members.

Present: Tom Buehler (Commodore); Tish Renz (Vice Commodore); Bill Knorp (Rear Commodore); Dave Pohlod (Secretary); Karen Edgley (Treasurer); Jeff Bosco; Caroline Oberndorf; Barbara Harris. Absent: Mary Jo Brumbaugh.

At 9:10am Commodore Buehler opened the meeting and apologized for the necessity of starting at 9am instead of 10:00am, as previously announced. The action was taken to satisfy the request of the Omena Historical Society that the sunfish race be rescheduled from Sunday to Saturday to accommodate the timing of their ice cream social and Mayor of Omena festivities. No objections to the revised starting time were voiced. The Commodore continued his remarks by requesting a moment of silence for members Nancy Bosgraaf and Mary Louise Root, both of whom passed away during the past year.

The Commodore announced that member Tom Oehmke would act as the inspector of the election and asked that those holding proxies present them to the inspector for certification. Subsequently, Mr. Oehmke assured that all proxies were properly verified.

The Commodore mentioned that the Club's initial articles of incorporation were established 60 years ago, and he requested that any descendants of the founders stand and be recognized. Several descendants accepted his invitation.

Commodore's Report: The Commodore commented on the progress that had been made by the Club during the past year. He mentioned that the former flagpole was replaced by a substantially stronger and well grounded flagpole that he considered a one hundred-year asset. The cost to the club was \$2800. He mentioned that the need to paint the restrooms will be deferred until the fall, at a cost of

about \$400. He reported on the need for renovation of the finger piers because of rotting wood and structural and safety issues. It was noted that the new finger piers may be removed relatively easily if bollards need replacement in future years. The cost of the reconstruction was indicated at \$3600, and the piers are considered a forty-year asset. He mentioned that the Board had approved all of the above measures.

The Commodore indicated that the Board had met with the Liaison Committee on June 19, 2009. As a result of this meeting, three recommendations were approved. These recommendations included the placement of an ad in the GTYC's web-based newsletter. The Board agreed to investigate membership associations with appropriate yachting associations, and invited suggestions from the membership. One of the associations being evaluated is Yachting Clubs of America, with 400 member clubs. The Commodore suggested members visit the YCA website (www.YCAOL.com). It was mentioned that a membership to the YCA would cost \$400 a year, and there are different levels of reciprocity depending on the needs and facilities of the applicant. Third, it was agreed to develop a questionnaire regarding member interests, including interest in associations with other organizations. The Commodore invited members to submit topics of interest for the questionnaire, which will be placed in the December Breeze.

Jeff Bosco was asked to speak and stated his interest in bringing closure to the issues raised by the Liaison Committee and acknowledged the substantial amount of work done by the Committee. He indicated the Liaison Committee has stated that it wishes to move forward. He observed that the Liaison Committee wanted to propose some additional recommendations for the Board's consideration:

 Notify membership of all Board Meetings ten days prior to the meeting.

- Minutes and motions should be posted on the website and bulletin board.
- Invitations from other clubs should be posted and kept on file, with member input prior to the Board decision.
- A proper form for use of the club should be submitted to the Board.
- Investigate potential memberships in appropriate yachting associations.
- Bring to membership any policy recommendations before adoption.

Dennis Turner moved that "we thank the special committee and especially Mike Biskupski for its work on a Herculean and thankless task, while often being subjected to criticism." It was seconded by Bill Cron. The Commodore approved the motion, with the membership's agreement.

The Commodore continued his remarks by noting the importance of continuously evaluating the Club's vendors, particularly high cost vendors such as insurance providers. In this context, the Commodore indicated that the Board had approved coverage from the Larkin Agency at a cost savings of \$2300 versus the prior year. The new policy provides an increase in our building insurance from \$550,000 to \$650,000, including \$325,000 for code updates and an increase in D&O insurance from \$500,000 to \$1,000,000. The Commodore said the sunfish are in bad condition and the OTYC is considering self-insuring the boats. He also noted the need for a sailing instruction boat.

Committee Reports:

Youth Program: Tami Bosco reported that attendance has been slightly lower than last year (8 – 18 members) due to initial inclement weather, but the program is going very well, and the new head instructor, Dave Capron, is doing an within

excellent job. She mentioned Dave is a Suttons Bay High School teacher with a lifelong involvement in water recreation. Several members have children acting as counselors and junior counselors for the program. Amanda and Taylor White are acting as co-directors with Dave. Counselors and junior counselors included Caroline Gulsby, Claire Edgley and Nina Lingauer, Katherine Edgley, Maggie Magrini, Brandon White and Madison Duff. The camper of the week program is very popular, and the campers are also planning a dance with a DJ on August 1.

The Commodore briefed the members of a recently adopted policy under which the club will pay one-half of the tuition cost of lifesaving training for junior counselors. The purpose and intent of that program is to insure that our juniors have a vested interest in water safety, and to promote successorship among the junior and senior counselors in order to insure the successful continuation of the program. Membership: Kanda McKee was not present, but her membership report read by the Commodore indicates the club had six resignations and seven new members this year. The Moffets have applied as Legacies. Membership is 288 at present, with a target previously established of 285. Larry Reynolds inquired about the initiation fee for a guest member who becomes a full member two years. He asked about grandfathering the initiation fee at the level in place when the guest membership begins. The Board agreed to look at the policy and get back to Larry.

Jim Miller made a recommendation that guest members automatically get to pay the initiation fee in effect when they become guest members when they become full members. It was pointed out that some guests do not join for years, and initiation fees could have been raised more than once during that time. Member Joan Brovins stated that her guest member packet had complete details and that she understood that the initiation fee could be raised if she delayed full membership. Ms. Brovins pointed out the Board has the sole ability to establish initiation fees to be paid from time to

time. She encouraged the Board to continue to spell out the details of the policy in the guest packets and in the Breeze to avoid surprises. Director Barb Harris indicated that she had been chair of the membership committee for 15 years. During this time, she believed guest members were charged the initiation fee in effect on the date when they became guest members and not when they became full members one or two years later. The Board agreed to look into the present policy and provide clarification to the membership

Social: Charlotte Read was not present to provide a report, but the Commodore mentioned Charlotte's earlier comments that the opening dinner hosted by Laura Deibel and Melissa Chenault was outstanding, with food prepared by Peggy Donaghy, and the potlucks are all very well attended.

Breeze: Tish Renz reported that she has spent a lot of time putting out the Breeze, but appreciates the input from many members, making the editor's job much easier. She particularly thanked the Turners, previous editors, for all their help with the Breeze. Tish, as future Commodore, is looking for a club volunteer to become the next editor.

Tennis: John Smart reported that the cracks in the court due to extreme winter weather have been repaired at a cost of \$1800. He also pointed out that a complete remake of the court would cost approximately \$40,000. John recommended that we continue to maintain the current surface as needed and periodically consider repainting the surface. The court is getting lots of use, and the tennis tournament begins next week. George Husted added that he needs more women for the mixed doubles events.

Grounds: Bruce Balas was not present, but Judy Balas reported that the volunteer work party went very well, with 20 people working on planting and cleanup. The Commodore added that the grounds look beautiful, and that more of the "heavy lifting" jobs (e.g., launch ramp) are being done by professionals, as the membership ages.

House: Marsha Buehler reported that a few screens have been repaired, but the house is in good shape. There is a water quality issue that is being addressed with a filter that will be installed soon. Marsha noted that it was very difficult to open the club in early May for an event, as we did this year, since the weather was so cold, making it difficult to get workmen to do the opening jobs. She said the same weather issues affect late fall events, making it harder to get the club winterized before the weather becomes too cold. She recommends that no events be planned before late May or after late September/early October. She also said that the cleaning person the club has used is ill (Rose Popp) and a new person is being trained. She encouraged people to clean up as they see things out of place. Barb Karchon has volunteered to be the new purchasing agent for the club. There is a sheet in the kitchen where members can add supplies that are running low. Waterfront: John Mitchell reinforced the Commodore's earlier message that the pier project is a major improvement to the waterfront of the club and much appreciated. The club has several boat slips available for short term rentals, two weeks for \$200. With the water level up significantly, these slips have become more desirable, with commitments from three families thus far. The club boat, the Alan Read, is being maintained and stored after the season at Manitou Marine, which means much faster service when issues arise and less downtime for the youth program. The Commodore indicated that this process represented an improvement over the previous expenditure of time and effort by club members to maintain the club boat.

Treasurer: Karen Edgley reported the club has approximately \$65,000 in the current account as of July, reflecting the dues income, and this will be reduced as expenses are paid. The club has three CD's for \$5,600 each, in its rainy day fund. At the end of the fiscal year in December, club assets were \$60,000 less \$48,000 expenses, for net income of \$12,000. There are no large expenses

The OTYC lost an active and enthusiastic member with the death of Mary Smith this fall. Mary was a member of the Club since 1973, when she married Tom Smith. From the beginning, she volunteered to be a potluck hostess, and other jobs that came along. After she and Tom moved to Omena year-round in 1987, she started the tradition of the fall apple-picking party in the Smith Orchard. This was usually held on the same day in October as the closing cocktail party at the Club, so OTYC members in the area for that weekend had a full day of fall fun. When the annual cross-country ski outing in February was organized, Mary and Tom were one of the first hosts of the catered chili dinner that followed. She was a frequent host of the OTYC catered dinners when they used to continue into the winter, and were held at someone's house once a month. For years, she was the treasurer of the Omena Woods Association, and also was active in the Omena Women's Club.

Mary was born Dec. 24, 1921 in Cincinnati, Ohio, the daughter of Lester and Mary F. Mac Pherson Aler. She graduated from Norwood High School, attended Marietta College and received both a Bachelor of Science and Master's degree in Chemistry from the University of Cincinnati. She worked at Palm Brothers Decal Co., the Drackett Co. and Procter and Gamble. She was named in a patent in 1964 for an improved silver polish.

Mary will be truly missed at OTYC.

foreseen, and the Board has voted there will be no increase in dues next year. Suzie Mulligan requested a copy of the budget and she was told that she would be provided a hard copy when the final budget was available.

Nominating Committee: Nancy Cooper was not present, but the nominating committee recommended that two Board members be reelected for their second three-year terms (Karen Edgley and Caroline Oberndorf), and that Stuart Saxton Williams be nominated for a new term, replacing Mary Jo Brumbaugh. Tom Oehmke acted as election inspector, counting and validating proxies from members according to Roberts Rules. While he was completing this process, the meeting continued with New Business.

Trish Bosco announced Tie-Dye Tuesday next week from 4 to 6. As a fund raiser for the Club, Marsha Buehler opened the OTYC store, selling shirts, mugs, hats and barware.

Dennis Turner recommended postponing the sunfish race until Sunday July 26 due to the extreme wind and cold. Skipper meeting at noon, race at 1. The gourmet hot dog sale will be held that day also. This change will be posted at the club and in Scuttlebutt.

Approval of 2008 Minutes: The minutes from the 2008 annual meeting were approved by the Board and published in the Breeze and on the OTYC website. A motion to approve the minutes was made by Judy Pohlod, seconded by Mary Tonneberger. Suzie Mulligan insisted that the minutes be read out loud. It was noted that the reading of the minutes has not been

done in recent years, and Bill Sandt said this is not necessary since they are published in two places, along with the financial statement. However, Kathy Bosco said minutes were read aloud during her tenure as Commodore. The Secretary then read the minutes aloud. Judy Balas stated that there was an error in her treasurer report. There was \$42,000 in the checking account and \$16,000 in CD's, but no additional preservation fund. The Secretary will amend the 2008 annual meeting minutes to correct this error. With no other issues, the minutes were approved by voice vote.

Election of New Board Members: The election inspector said the count was finalized (attached) and read aloud the number of proxies for individual members. The election of Board nominees was conducted, and the nominees were unanimously elected.

Commodore Buehler thanked his Board for their dedication to the Club and their hard work on many difficult issues during the past year. Jeff Bosco thanked the membership for a positive annual meeting, and thanked the Commodore for the great condition of the Club and for conducting a very positive annual meeting. A motion to adjourn was made by Judy Pohlod and seconded by Mary Tonneberger. Meeting adjouned at 10:50am.



Note from the editors:






Youth Dance!!

From your Membership Chair.....

The following junior members, born in 1986, will become eligible in 2010 for membership as Associate Members of the OTYC. They will no longer be eligible to be a Junior Members.

The OTYC By-Laws define an Associate member as a person age 24-30 and his/her spouse, if any, who has been a junior member each year since eligible. A junior member cannot retain his/her junior member status in the year that he or she turns 24. (A child becomes a junior member in the year they turn 14.)

One of the benefits of becoming an associate and maintaining that status until the age of 30 is that the associate member will not have to pay the initiation fee to become a full member. The associate would also be able to attend any OTYC function without having to attend as a guest of a full member.


The amount of a single Associate Member dues is \$70.00.


